**EL:** No, but this-- yeah, no, this one I think it was [inaudible], but maybe, I don't-- I don't know. Yeah.

**JH:** So do you wanna go inside or should we sit out?

**EL:** [inaudible]

AT: Yeah, it's nice outside.

**JH:** Yeah, just pull a-- just put a chair here. Do you wanna get something to drink or...? We're, like, in a bit of a hurry-- I mean, going to the festival grounds really soon, but it's nice to--

**SH:** Yeah, it's-- it's going really well. Um, yeah, we just-- we wanted to talk about, just in general, what's going on--

**AT:** Yeah, I mean, like, I don't know. I-- it's just, like, it's been really difficult communicating with you, like, for a while now and, like...I'm, like-- I'm-- I'm pretty, like, frustrated at this point, 'cause, like...you're representing him and this is, like, huge--

AT: It's just, like, there's a lot of stuff going on and, like--

EL: Yeah.

**AT:** Henrik's, like, not one of the pe-- not one of the artists that can really, like, fend for himself or knows what's going on, and we try not to stress him out with any kind of, like--

EL: No. No, we're not stressing--

in touch with you--

EL: Yeah.

**AT:** ...and it's been difficult.

**EL:** Since, like, we don't really have [laughs] anything to say yet, because we don't really know anything yet--

AT: I know, but don't you wanna-- like-- I mean, don't you wanna know what's going on with, like...

**EL:** [hesitantly] Yyyyye....

AT: 'Cause, like, this is -- like, this is a huge project--

EL: Yeah.

**AT:** Like, it's, like, reaching into the US market, something that he's never--

EL: Yeah.

**AT:** ...made it to before.

EL: Y-- yeah, yeah, yeah.

**JH:** I guess, since there have been so many loose ends on our side, we don't really know how to-- it's been kind of paused on our part, so I'm not really sure what...kind of information--

EL: Yeah.

**EL:** ...and with the album, so that's where we are right now, because we-- Yeah.

**AT:** Yeah, but I thought he signed with you guys in, like, November.

**JH:** Ehh...

**EL:** No, but we... No, not-- no, we didn't have, like-- no, we didn't really sign in November. That was this-- this spring we started working with him, so...yeah.

JH: And since that h-- I mean, since the record deal isn't in place yet--

EL: Yeah.

JH: ...I mean, we have so many projects that we work on--

EL: Yeah.

JH: ...constantly. I mean, music, films... So that has been kind of, like, on hold on our part-

**JH:** ...uh, for a while. 'Cause I don't know-- I don't think Henrik has a lot of--

**EL:** Yeah, but we-- we-- no, we have-- th-- the thing is, like, uh, this has been, like, going on for years. I mean... And we don't-- like, this could take, like, another two-- I don't think so, but it could take, like, another year before we release the album. I mean, it was, uh-- Uh, all the songs, they are not-- they were supposed to be, like, uh...done in June, but now, I think we have to... We have, like, three or four of them. I think it would take a couple more months before we have the whole album. So we are still, like, in the beginning of the process, so it's really hard for me to

really say anything. It's like, yeah.

**AT:** I mean, it's just, like, I'm-- you know, we come from the music industry in the US and, like, I'm accustomed to going through, like, management and the publicists and all for artists in terms of, like, what's going on, like, especially a massive film project like this--

AT: But I can't-- I can't t-- I can't send-- I can't say these things over email. They're like--

EL: Okay, but you can tell us now.

AT: ...There's, like, a lot of stuff going on--

EL: Please tell us.

**AT:** I don't-- I don't know. I don't know if I really, like-- I don't know if I want to get into it, because it's like... Something I've noticed here, which is very different from the US, is, like...all the people in the music industry here are, like, connected in this political way that, like, makes me really uncomfortable--

**AT:** ...And some of this, like, information that I have, like, I'm not sure, like, who you guys are friends with or, like, I don't want anything that I know to be passed along that, like--

EL: Okay.

AT: ...could be problematic for other people and--

**AT:** ...it's, like, really just a matter of, like, relationship and sharing information. Like, this is a massive project--

EL: Yeah, yeah--

**AT:** ...and, like, I, like-- you know, like, I wanna, like, connect Henrik with all of our contacts in the US and stuff--

EL: Yeah.

AT: ...and it's like, I couldn't get-- like, I understand that you guys have vacation, but, like--

**AT:** ...when I'm sending you emails saying, like, "This is, like, really important--"

EL: Yeah, but I think it's, like--

AT: ...and, like, I don't get a reply...

**EL:** Yeah... But, um... Like, it's really hard for us to say anything before-- before the deal is set. We have-- we have, like, no record deal, and it's just because we want to have, like, uh, the best deal, of course--

AT: Right.

EL: ...so that-- before that, I can't-- I can't really anything--

AT: But I have information about all-- I have information about all the labels for you guys--

**EL:** Y-- yeah, yeah, we ha--

**AT:** I don't want anything to do with, like--

**EL:** No, but we have, of course-- we have the information about the Swedish labels, of course, so-- so, yeah.

**AT:** But I have information about, like, l-- ab-- about lab-- about all the labels that you guys are talking to. Like, we're deeply ingrained in all of these people--

EL: Okay.

AT: ...and, like, there's a lot of--

**EL:** Wh-- tell us-- what do you want to tell us?

AT: ...stuff going on.

JH: Yeah.

**EL:** Tell us about the stuff. [laughs]

**AT:** Hm. I really, like-- I don't know.

SH: The issue is-- is that the...the information pertains to a lot of really contentious, like, decades-old histories, um, with some of the people that I know that you're talking to, and I know that...you know, these conversations are ongoing and that, you know, I... You know, I'm not-- I'm not--

I just, like, don't feel super comfortable, like, sharing this information now just 'cause it's been so difficult to, like, have any kind of relationship with you guys and, like, I just, like-- we felt really disrespected, like, since you, like, you know-- What-- Our last conversation, we were telling you all the things that we can, like, help you guys out with and all these, like, connections--

AT: ...and all this information we had. And then it was just, like, radio silence.

**EL:** No, but we-- we have to start with Sweden. We have to do it, like, our way and then we get back to you. And, like, it really need to be, uh, set up as really. And, like I said, I can't really say anything. After we have signed this deal, that would be so much easier for us to talk. And then we can, like, talk, like, uh, US and blah blah blah, but right now, we have to do this in Sweden. It's...it's--

**JH:** And also, your suggestions, I mean, we-- we read through your, um, the-- the entire kind of, like, proposed-- proposal, but-- but, um...um, and that was-- was with, um, which label?

EL: Uh, Luxury.

**JH:** Luxury. And, I mean, they had the opportunity to-- to--

**EL:** Yeah, we-- we reached out to them, yeah--

**JH:** ...present, like, a proposal [inaudible] but it-- that didn't come in and, because we want to get

things moving, we-- we needed to, uh--

EL: Yeah.

**JH:** ...go forward with other...you know, projects, so-- or--

**EL:** And that is not only me, it's the, uh, United Stage. It's Anders Larsson and he is, like, talking to so many people. He has been in the industry for, like, 45 years. So, like, there is things going on and I can't really say anything before it's, like, set.

AT: But again, it's, like, an issue of, like, non-communication. Like, it's just, like--

**EL:** [inaudible] but nothing we have to say. It's, yeah--

**AT:** I know, but, like, it's just a matter of, like, I'm s-- I'm, like, sorry, like, I, like... I, like, g-- I can't do anything right now--

EL: Yeah.

**AT:** I was getting, like, radio silence from you a number of times.

EL: Yeah.

**AT:** And, like, that's just, like, not-- that's not how...

SH: I mean, I think for us, the concern is, like, you know, we're not trying to get in the middle of these negotiations—

**SH:** ...but the fact of the matter is-- is that these two things are intrinsically linked to one another, and so--

**AT:** We're just looking out and, like...we have so much information, like, and we've been so close to Henrik for two years with this, like, project, like, I...we also-- we're not just filmmakers, we have, like, indus-- like, major industry experience and connections. Like, I understand what's going on and, like...we are just trying to look out for him and make sure that all of the, like, information is there for his management team--

AT: ...to be, like, processing--

**JH:** Yeah, but then, if you have sensitive information that you think will benefit Henrik that we know of, we-- you need to tell us, because we can't really do much--

**AT:** I was try--

JH: ...'cause we need--

**AT:** I was trying to tell you guys like a month ago, and I said, like, "I don't feel comfortable saying this over email. Like, I want to--"

EL: Yeah, but now we're here. So let's talk. [laughs]

**JH:** We have been-- I mean, in Sweden, when people go on summer holidays--

EL: Yeah, they go away for, like--

**JH:** ...like, our only weeks that we--

EL: Absolutely. We have, like, four weeks in July and, yeah, that's it.

JH: And that's the Swedish standard--

EL: Yeah.

**JH:** ...so then, we kind of, like, sign off--

**EL:** People do that. We have family and we have kids, so that's what people do in Sweden.

**AT:** I know, but Ebba, I sent you an email that was like "I have, like, some s-- like, really sensitive information--"

[00:11:01] EL: Yeah.

AT: "...and I need to talk to you," and you just, like, didn't answer.

JH: But it's difficult to know--

**EL:** No, but I have two kids, and then you are, like, in the countryside and things happen, some, like, family come over. It's like you only have, like, your three or four weeks, and you have to, like, close everything down. And, yeah--

AT: I understand that--

EL: Yeah.

AT: ...but I sent you a really, like, urgent email and you just didn't answer--

**EL:** But let's move forward and tell me. I mean, we are really interested and we are really, like, keen on, of course, knowing, because...we care about Henrik as well...as much as you do, and we want this to, like, work out really great...of course. And with the film and with the book and with the album and, yeah, in Sweden and-- and US, so...

**AT:** It's just, like, this is a really pressing issue--

EL: Mm-hm.

**AT:** Like, again, like, the US market is, like, 30 times the size of the Swedish market. Like, it just seems like something that would be a bit more of, like, an urgent matter, like, for you guys to, like, have information about.

AT: 'Cause, like, I've been in contact with you since November...

EL: Yeah.

**AT:** ...was when Henrik put us in touch--

**EL:** Yeah, but—but yeah, but we didn't—yeah, but then he didn't—he—he started, like, recording the album in April. So before that, it's like black. We didn't have anything. It was just, like, a discussion between us, so—

EL: Yeah.

JH: So--

**EL:** For, like, 10 years.

**JH:** I mean, it hasn't been-- like, it hasn't s-- kicked-off--

**EL:** Yeah, it hasn't kicked-off yet. And I think he could take, like, another six months or even more. It depends on what's happening--

JH: But of course, we're gonna go through in-- more into a management role--

JH: Yeah, but it's not set yet--

EL: We're not there yet.

JH: ...because we haven't-- we haven't the deal in place and everything, like we said, so it's not--

**EL:** We don't-- we don't have the music.

**JH:** I mean, I-- I understand, from your point of view, that you think that, I mean... Uh... Yeah, I can understand that, but, I mean, we haven't really, you know, set the kind of, I don't know, the structure for...for his, like...

**AT:** So again, I mean, what you're saying is that you're not really, like, actively managing him right now then.

JH: Well--

**EL:** [hesitantly] Yyyyeah, of course we are, but we are still waiting for stuff, so we can't, like, really--

AT: Right, but those are two separate things. Like, the a-- the actual record, like--

**EL:** But-- b-b-but what's-- [laughing] I don't really know what you're talking about, to be honest. It's like, uh... Uh... I don't really get this. [laughs]

**AT:** Well, if-- like, when there's an-- like, when there's a big entity with a lot of things attached to it--

EL: Yeah.

**AT:** ...like, centered around a client, it's just surprising not to hear from the management to be, like, asking questions about it, figuring out what's going on--

**EL:** But we have asked questions about the film and I am really interested, but you didn't really answer that when we, like-- "What's going on?" Because I saw this was-- it looked great. And I really-- and I talked to you about, like, the, uh-- and I talked to Henrik about if you need, like, distribution in Sweden, and I have great contact with Folkets Bio and st-- yeah.

AT: W-- that's not-- this has nothing to do with the film--

EL: Mm.

**AT:** ...Like, the film is completely, like, its own entity--

**EL:** Okay, so this-- yeah.

**AT:** [inaudible] ...Like, we-- we have, like, a massive, like, team behind the film.

EL: Mm.

**AT:** Like, it's not about the film. It's just about, like...first of all, like, not hearing from, like, the management. Like, I just don't understand what you guys' role is with him, like, 100 percent. And then, like, also, we're telling you that we have stuff that, like, you should know that's going on behind the scenes with, like, all these labels, and then to have so-- such long radio silence, it's so difficult to get in touch--

JH: From my point of view, I don't think that, like, "sensitive information," it's not-- it's very vague, so I'm not s-- I mean, if you would be like "urgent information about the record deals that y--" or "the different--"

AT: I did-- I did say that.

JH: Okay. But--

**EL:** But-- b-but please tell us. I mean, we have, like-- if you're talking about Swedish labels, we have...uh, a lot of information as well. Uh...and, uh--

**EL:** I think-- then I think Anders Larsson should join as well, and Pontus Sill-- uh, Sillrén. I think it's really important, because they're doing all, like, the...um...*juridisk* [legal] stuff.

**JH:** Yeah, uh, the legal, uh--

**SH:** Okay. Yeah, that-- that...sounds like probably the way to go.

It's-- it's difficult to be able to talk about without us being able to share this information openly, but the reason why we kept kind of pressing on this-- the sensitivity of this information and the urgency is because...if it were to get out, it would...really affect a lot of...very delicate and...deeply-ingrained, um, issues of legality and, on a basic level, ethics that are very tied into the music industry here.

**JH:** Yeah, but it's a different thing in--

**AT:** ...and I understand that that's not how people do things here--

EL: Yeah.

**JH:** Exactly.

**AT:** ...but, like, it makes me really uncomfortable to, like-

EL: Mm, yeah.

**AT:** ...say things in, like, writing and stuff--

EL: Mm.

AT: Like, I mean--

**EL:** But when it comes-- of course, when it comes to Henrik, of course we wouldn't say anything. I mean-- yeah.

This is, like... I'm—we're being not-forthcoming right now, like, not for—to cover our own asses. Like, it's just...when you've been in the middle of a film for like two years with all these people and you glean a lot of information and...some of the things that have come to light in the last few months, like, they are ethical and legal issues that, like, I can't send over email and, like, I don't feel comfortable bringing up right now.

EL: Yeah, yeah, yeah.

JH: Maybe you-- maybe we have a idea of what it might be about.

EL: Yeah, yeah, uh-huh, yeah... S--
